Quotations should be accompanied by i) An EMD (in the form of Demand Draft/Call Deposit/TDR) of ₹. 2000.00 (Rupees Two Thousand) only drawn/pledged in favor of Registrar, Tezpur University, payable at Tezpur. No request for consideration of earlier deposited EMD will be considered. ii) A non-refundable application (quotation) fee of ₹.500.00 (Rupees Five Hundred) only must be paid only by Demand Draft drawn in favour of Registrar, Tezpur University payable at Tezpur.
- 4. The rates should be exclusive of taxes and applicable tax % should be clearly indicated.
- 5. Applicable levies, surcharge and discounts should be clearly indicated itemwise.
- 6. Quoted rates should be valid at least for a period of 01 year.
