1. Registered with Govt./Semi Govt. Departments/Autonomous Bodies .
2. Average Annual Turnover during for last 3 consecutive financial years shall not be less than **0.32 lakhs**.
3. Should have **completed** satisfactorily electrical works of (i) *one work* of value not less than **0.77 Lakh against single work order OR** (ii) two works of value not less than **0.48 Lakh** each against *two separate work orders OR* (iii) three works of value not less than **0.39 Lakh** each against *three separate work orders* during last seven years in Govt./ Semi Govt. Department/Autonomous Body supported by **work order and completion certificate**.
4. The tenderer shall sign and stamp each page of this tender document as a token of having read, understood and comply with tender, the terms and conditions contained herein. This tender document is required to be uploaded on the website <https://eprocure.gov.in> **along with scanned copies PAN, GST and other qualifying documents, as per the qualifying criteria stated above in serial no.1,2 and 3.** Incomplete bid/documents shall be rejected without giving any reason. **There is no need to submit the hard copy of the Tender and other documents except Original Bid Security Declaration & Declaration regarding correctness of information submitted in this Tender as per NIT in affidavit (As per Annexure VI) and Tender Fee (non-refundable).**

6. **Original Bid Security Declaration & Declaration regarding correctness of information submitted in this Tender as per NIT in Affidavit and tender fee (non-refundable)** must be submitted in a sealed envelope to be super scribed this tender name & the name of your agency and must reach *The Registrar, Tezpur University* before the last date & time for receipt of Bid. ***Tender without the Bid Security Declaration and Tender Fee (Non-refundable) will be summarily rejected.***
7. **Bidder's Technical capability will be determined as per the format given in Annexure-VII. Technically disqualified bidder's price bid will not be opened and will not be considered for the next step.**
