Should have **completed** satisfactorily Civil Works of (i) *one work* of value not less than **3.73 lakhs** *against single work order* **OR** (ii) two works of value not less than **2.33 lakhs** each against *two separate work orders* **OR** (iii) three works of value not less than **1.86 lakhs** each against *three separate work orders* during last seven years in Govt./ Semi Govt. Department/Autonomous Body supported by **work order and completion certificate**.
- 4. The tenderer shall sign and stamp each page of this tender document as token of having read, understood and comply with tender, the terms and conditions contained herein.
