Bids in 02 Bid System (Technical and Financial) are invited on GeM from interest vendors for supply of welcome (toiletries) kit for guest House of Tezpur University, Assam – 784028.

Please read the Bid document carefully before participating. It shall be deemed that submission of bid by the bidder has been done after their careful study and examination of the Bid terms with full understanding to its implications. Any lack of information shall not in any way relieve the bidder of its responsibility to fulfill its obligations under the Bid.

The University will reject a proposal for award if it determines that the bidder recommended for award has engaged in corrupt or fraudulent practices in competing for, or in executing, the Purchase Order. Fraudulent Practice means a misrepresentation of facts in order to influence a procurement process and includes collusive practice among bidders (prior to or after Bid submission) designed to establish Bid prices at artificial non-competitive levels and to deprive Tezpur University of the benefits of free and fair competition. Corrupt Practice means offering, giving, receiving or soliciting of anything of value, pressurizing to influence the action of a public official in the process of this purchase execution.

GENERAL TERMS & CONDITIONS:

- 1. The items desired to be procured through this bid are supplementary to each other and in execution of the project in entirety, as such interested participants may note that they are to quote for all the items as desired to be procured through this bid.
- 2. Quotations should be accompanied by
 - (a) An EMD (in the form of Demand Draft/Banker Cheque) for **Rs. 17000/-** (i.e. 2% of the estimated value) (Rupees Seventeen Thousand) only drawn in favor of Registrar, Tezpur University, payable at Tezpur. No request for consideration of earlier deposited EMD will be considered.
 - (b) Bidders who are MSME/NSIC registered needs to furnish a "Bid Security Declaration" (format enclosed at Annexure – II) in lieu of EMD accepting that if they withdraw or modify their bids during period of validity etc., they will be suspended for a period of Three (03) years from participating in any future bid invited/published by Tezpur University. Bidders whe are MSME/NSIC registered seeking exemption from payment of EMD are to submit valid documents in support of their claim. Bidders seeking exemption are asked to clearly mention the category under which exemption is claimed. The category of exemption under MSME/NSIC will be strictly adhered to.
 - (c) The original copies of the EMD/Bid Security Declaration should be deposited/submitted/reach the office of the undersigned before opening of the Bids in an envelope superscribed as "Quotation/Participation Fee and EMD for <u>TU/GEM/BOO-BID/(184)/2022-</u> <u>23/.....</u> addressed to the Deputy Registrar-GA, Tezpur University. Failure to do so may result in rejection of the bid.
- 3. Bidders/Tenderers are to ensure that they are GST compliant and that their quoted tax structure/rates are as per GST law. The rates should be exclusive of taxes and applicable tax percentage should be clearly indicated. Financial/Price Bid format where taxes cannot be mentioned separately, in such cases, the percentage of taxes applicable should be mentioned in the Technical Bid document.
- 4. Validity of Quotation: Quoted rates must be valid for at least 180 days from the last date of submission of quotation.
- 5. Applicable levies, surcharge and discounts should be clearly indicated item wise.
- 6. **Dealership Certificate:** Dealers or Agents quoting on behalf of Manufacturer must upload valid dealership certificate.
- 7. Genuine Pricing: Vendor is to ensure that quoted price is not more than the price offered to any other customer in India to whom this item has been sold, particularly to Universities/IITs/Institutes and other Government Organization.
- 8. **Payment**:100% payment after successful delivery of the items as per requisition (Purchase Order) to be issued separately.

- 9. **PENALTY FOR DELAYED DELIVERY**: The date of delivery should be strictly adhered to. In the event of delayed delivery, installation & commissioning, the vendor shall be liable for a penalty deduction as per prevailing rule.
- 10. Irresponsive/incomplete quote will be rejected.
- 11. Conditional tenders not acceptable: All the terms and conditions mentioned herein must be strictly adhered to by all the vendors. Conditional tenders shall not be accepted on any ground and shall be rejected straightway. Printed conditions mentioned in the tender bids submitted by vendors will not be binding on Tezpur University.
- 12. Enquiry during the course of evaluation not allowed: No enquiry shall be made by the bidder(s) during the course of evaluation of the tender till final decision is conveyed to the successful bidder(s). However, the Purchase Committee or its authorized representative (Tezpur University) can make any enquiry/seek clarification from the bidders. In such a situation, the agency shall extend full co-operation. The bidders may also be asked to arrange demonstration of the offered items, in a short period notice, as such the bidders have to be ready for the same.

Termination for default: Default is said to have occurred:

- a. If the equipment or any of its component is found having poor workmanship, faulty designs, poor performance and bad quality of materials used.
- b. If the supplier fails to deliver any or all of the services within the time period(s) specified in the purchase order or any extension thereof granted by Tezpur University.
- c. If the supplier fails to perform any other obligation(s) under the contract.
- d. Under the above circumstances Tezpur University may terminate the contract / purchase order in whole or in part and forfeit the EMD/PBG as applicable. In addition to above, Tezpur University may at its discretion also take the following actions: Tezpur University may procure, upon such terms and in such manner, as it deems appropriate, goods similar to the undelivered items/products and the defaulting supplier shall be liable to compensate Tezpur University for any extra expenditure involved towards goods and services obtained. Besides, the Vice-Chancellor, Tezpur University, and reserves the right to impose any other form of penalty as deemed fit including blacklisting of the vendor.

13. Selection criteria:

i. Evaluation Criteria:

To ensure that each bidder has the necessary qualifications and resources to full fill its obligations under the contract, the following criteria shall be evaluated. The Eligibility, Financial, Experience & Support criteria should be passed before the technical criteria. Technical criteria will be evaluated and ranked by the award of ACCEPT and/or REJECT. Only the ACCEPTED vendors will be considered for price bid. In case a joint venture makes a bid, any one of the members of the joint venture need to be qualified for each of the criteria mentioned below.

ii. Non Blacklisting Criteria:

a. The bidder or the OEM should not be blacklisted by Tezpur University or any other Educational /R&D/ PSU/ Govt organizations. A certificate or undertaking to this effect must be submitted.

iii. Financial bid evaluation

Technical bids will be evaluated and ranked by the award Accepted & Rejected. The price bids of Accepted vendors would then be considered by the concerned Purchase Committee of the institute **Delivery Period**

PART A GENERAL TERMS AND CONDITIONS:

- 1. Interested vendors/distributors/suppliers are to upload the registration form as enclosed in the GEM Portal.
- 2. The registration form should be signed by an authorized signatory of the vendor(s) bearing his/her full name & designation along with the official seal of the firm.
- 3. Incomplete and conditional applications will be summarily rejected.
- 4. At any given point in time, if any of the documents furnished by the vendors/suppliers is found to be false, it would deem to be a breach of terms of contract making the firm liable for legal action, besides termination of empanelment.
- 5. The bids shall be scrutinized and shortlisted for empanelment by the University, the results of which shall be uploaded in the GEM Portal.
- 6. The short-listed vendor(s)/distributors/supplier(s) for empanelment must agree to supply the items as per the Terms & conditions of empanelment order issued by the University.
- 7. The successful bidder shall have to submit security deposit of requisite amount (3% of the total work order) to be specified during placing of actual work order.
- 8. In case of failure to comply with the terms and conditions of the empanelment order, the vendorship shall be terminated and the security deposit shall be forfeited.
- 9. Vendors/distributors/suppliers must submit Audited Statement of Accounts of last three years duly endorsement by a certified Chartered Accountant.
- 10. The Vendors/distributors/suppliers must submit an undertaking in their company/firm letterhead stating that they have not been debarred for participation in any bids of PSU/ G.O.I. Organizations/Central Autonomous Bodies etc.
- 11. The quantity mentioned is approximate and the actual requirement may vary, which shall be communicated at time of order placement.
- 12. The total quantity of items as mentioned in this Tender notice is annual requirement figures and is an approximate quantity. However, bidders may note that the order shall be placed based on requirement. Rates may be quoted accordingly.
- 13. The University shall not consider any increase in rate of the items during the entire period of bid.
- 14. The bidders shall ensure that items to be supplied should be of reputed make/brand and of requisite quality. In no case, items of inferior quality shall be entertained/accepted by the University. The make/brand/quality as mentioned in the quote/bid shall be required to be supplied during the entire period of bid.
- 15. Successful bidder has to submit Performance Bank Guarantee of requisite amount, which shall be communicated at a later stage.
- 16. Bidder may note that for the financial bid, the price has to be quoted for the entire bundle of items as on "Welcome Kit" and not individual item wise. The price quoted shall have to remain valid for the entire period of empanelment and no change shall be considered during the bid period.
- 17. The empanelment shall be valid initially for a period of one (01) year from the date issue of notification of empanelment. Further, extension if any, would be communicated at a later period as per mutual agreement between the two parties.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. - 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for attached categories, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
