1. Bidder must be a registered contractor in any Govt./Semi Govt. Departments/Autonomous Bodies who award works to the contractors.
2. The tenderer shall sign and stamp each page of this tender document as token of having read, understood and comply with tender, the terms and conditions contained herein. This tender document is required to be uploaded on the website <https://eprocure.gov.in> **along with scanned copies PAN, GST and qualifying documents, as per the qualifying criteria.** Incomplete bid documents shall be rejected without giving any reason. **There is no need to submit the hard copy of the Tender Document and other documents** except Original Declaration regarding correctness of information submitted in this Tender as per NIT in notarized affidavit (As per **Annexure V**), Tender Fee (non-refundable) and Earnest Money Deposit(refundable)
3. Bidders will be required to upload the scanned copies of the Demand Draft against tender fee (non-refundable) and EMD (Earnest Money Deposit) drawn in favour of the Registrar, Tezpur University payable at Tezpur along with the Declaration regarding correctness as per NIT in notarized affidavit and other qualifying documents as per tender and sealed and signed tender document.
4. Declaration regarding correctness of information submitted in this Tender as per NIT in notarized Affidavit , Tender fee (non-refundable) and EMD (Earnest Money Deposit) must be submitted in a sealed envelope to be super scribed this tender name & the name of your agency and must reach *The Registrar, Tezpur University* before the last date & time for receipt of Bid. **Tender without the Tender Fee (Non-refundable) and EMD (Earnest Money Deposit) will be summarily rejected.**
5. **Before submission of the tender, Bidders must have to visit the site.**
6. **Bidders are required to upload the following documents. Non-submission will lead to disqualification of the bid.**
 - (a) EMD and Tender Fee.
 - (b) Affidavit for correctness of information as per Annexure-V.
 - (c) Bank Solvency Certificate in prescribed format (As per Annexure-III of this tender document) from any scheduled bank issued within 06(six) months prior to the date of publication of this NIT or after the date of publication of this NIT satisfying at least 25% (twenty five) of the value put to this tender.
 - (d) PAN.
 - (e) GST Registration.
7. **Bidder's Technical capability will be determined as per the format given in Annexure-VI. Technically disqualified bidder's price bid will not be opened and will not be considered for the next step.**

The work may be allotted in part or whole at the discretion of competent authority of the University.
